### 16<sup>TH</sup> ANNUAL CONFERENCE

2004 has been an interesting year for the airline industry with a substantial upturn in the market compared to the previous very difficult years. In Europe the major event has obviously been the enlargement of the European Union with 10 new member countries. This has already had an impact on the aviation industry and airlines in both the new member countries and the present European Union. It is therefore only appropriate that the European Air Law Association devotes time at the annual meeting for a detailed analysis of the consequences of the enlargement. The Association bids welcome participants from new member countries and the airline industry in those countries.

From a regulatory point of view the year has also been marked by the entry into force of a new European competition scheme with drastically changed procedural rules. The European Air Law Association considers these issues to be a core part of the Association's focus and has therefore established a panel, which will discuss the impact of the new regulatory scheme for the airlines and the aviation industry.

Low-cost carriers have again dominated the development in the industry. Already established low-cost carriers have expanded, the national carriers have set up their own low-cost carriers and new low-cost carriers have mushroomed all over Europe. At the same time issues have arisen as to the commercial agreements made by low-cost carriers and airports around Europe, which has again focused the attention on state aid. All these issues will be covered by a separate panel at the annual meeting.


In addition, we will focus on the development of the aviation industry in the host country, Germany, and also devote time to recent issues which will impact on the future development of the industry, such as the Air France/KLM merger and the status of the European/US open skies negotiations just after the American presidential election and the election of a new European Commission.

The conference will be held in vibrant Berlin in the historical settings of the Hotel Adlon, right at the Brandenburg Gate. You should not miss the opportunity to be updated on the airline industry and its legal regime, to visit Berlin and to use the annual meeting as an excellent venue for networking. We have also arranged tickets for those of you who are interested in a visit to the Berlin State Opera for a performance of Prokofiev's ballet *Cinderella*.
