EALA has since 1989 at its annual meetings presented a variety of legal and regulatory issues relevant to the airline industry in general. Since 1997 EALA has had the pleasure to arrange biennial seminars in Munich focusing on liability topics for the airline and aerospace industries. EALA now proposes to add a biennial seminar in Copenhagen devoting time and providing expert panels on legal issues of aircraft finance, the first one to be held on 29 September 2006. - Thirdly, repossession procedures and problems will be dealt with from various national law perspectives.
- Finally, a panel will review the most recent developments in taking security over aircraft and its various components.
